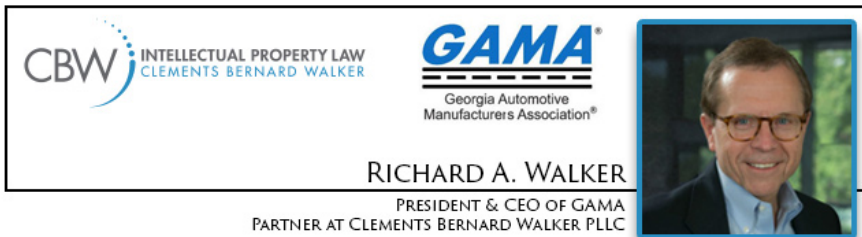




Upcoming Program
